Web Site

Home Improvements

You may be thinking about improvements to your home and property. Please keep in mind that all property owners must receive approval from the Board <u>prior to</u> undertaking the addition of any <u>outside</u> structures. Residents need to contact the Board and submit plans for the structure. The Board has 30 days to review the plans submitted and issue a decision (typically it does not take that long). Do <u>NOT</u> start construction or wait until construction is ready to begin before you start the approval process with the Board. Doing so might cause your project to be delayed or perhaps dismantled if the proposed project does not meet the requirements in the CCR's.

On a related note, if you are planning a roof replacement, please be aware that the CC&R's in Phase 3 <u>require</u> a dimensional shingle be used while in Phases 1 & 2, it is optional.



Here to Help

A goal of this Board is to be of service to residents. To that end, the Board will help residents when they need help. Examples include the following:

- Need your grass cut because your mower stopped working, you are going on vacation, the person you had lined up to cut the grass is not able to get it done? Email the Board, and we will send a note to all residents to see if someone can help.
- Need someone to walk your dog or other pet? Email the Board, and we will send a note to all residents to see if someone can help.
- Have a mechanical issue such as no heat/AC, plumbing issue, electrical issue at your home? Email the Board, and we will send a note to all residents to see if someone can help or recommend a company.



Parking Reminder

A quick reminder about any vehicle, utility (trailers), pleasure (campers, RV's), or otherwise, that is parked or stored on properties in Greenfield Estates. It is limited to <u>no more than seven (7) consecutive days</u> unless it is within your garage or other enclosed area. Also, inoperable vehicles are not permitted at any time unless they are in an enclosed area. See item 15 of the CC&R's for more details.

Vacation Check Program

Going on vacation and wondering if your property The Fairfield County Sheriff's will be ok? Department has a Vacation Check Program where a deputy checks your property at least one time each day while you are gone, and they will stop by at any and all hours. This is a free service for all Fairfield County residents. This action, in addition to asking your neighbor(s) to watch things plus stopping your mail and newspaper deliveries, is another way to keep your property safe. The service additional visibility also provides of enforcement in our neighborhood. When you return from your vacation, you should receive a letter indicating the dates and times the deputy visited your property. For more information, call 740-652-7300.
