CC&R Changes/Updates

The Board of Trusteed believes that it is time to update the Covenants, Conditions & Restrictions (CC&Rs) to address new challenges facing Greenfield Estates. Specifically, prohibiting the use of our residential properties as short term rentals such as *VRBO* or *Airbnb*. The process would require legal guidance and a majority of the homeowners to approve the final product. The Board believes that acting now might preclude any future issues. The annual meeting will be held in the Spring of 2023 where we can address and discuss a proposed draft.

Since there are several new families in the neighborhood, we would encourage you to review the current CC&Rs prior to making changes to your property. Common issues that come up include: 1. Plans for any outdoor "structure or thing" on your property must be presented to the Board of Trustees in advance for consideration and 2. Residents are to maintain their property. All trees, shrubs, grass and plantings shall be kept well maintained, properly cultivated and free of trash, weeds, and other unsightly material.
